### 1. ITCO Divisional Meetings – January 2021

ITCO's Membership consists of four Divisions: Operators, Leasing Companies, Manufacturers and Service Providers. All ITCO Members are members of one of these four Divisions.

Normally, Meetings of these four Divisions take place at our Annual Meeting - when Members of each Division can discuss issues of common interest and propose future ITCO projects and activities.

As it has not been possible to organise a Members Meeting this year, we will now be organising the Divisional Meetings as Video Calls in January. Arrangements, dates and agenda are as follows:

#### ***Practical Arrangements***

- The Meetings will be organised using Zoom.
- Each Meeting will last about **about 1 hour**
- Members will need to register to participate in their Meeting.
- Divisional Chairmen and Vice-Chairmen will moderate the sessions, manage the agenda, etc.

#### ***Agenda***

- The aim of the Meetings is to permit Members of each Division to discuss common issues and consider future ITCO projects.
- Members will be invited to propose items for the Agenda of their meeting.
- The Agenda for each Divisional Meeting will be prepared and circulated in advance

#### ***Dates***

- The meetings will take place as follows (two meetings per day, times to be confirmed):

**Tuesday 19 January 2021:** Operators and Leasing Companies

**Wednesday 20 January 2021:** Manufacturers and Service Providers

- Members will need to register to participate in their Members Meeting

## **2. Tank Container Village at *transport logistic 2021*, Munich – Status update**

Next year's *transport logistic 2021* exhibition is still scheduled to take place in Munich, from 4-7 May 2021. While recognising the uncertainties about travel, events and public meetings throughout Europe next year, arrangements are going ahead to organise the Tank Container Village at the Show.

In view of the uncertainty caused by the Covid-19 Pandemic, the ITCO Secretariat is continuing to monitor the situation very closely. We are in regular contact with MEPLAN (the Exhibition Stand Managers) and Messe München (the Event Organisers).

The Secretariat has been informed that a decision will be made about the event "in January". In the meantime, ITCO is continuing to take bookings for Members who wish to reserve a stand in the Village.

There is no financial commitment yet– reservations are only on a "provisional" basis (no invoices issued or payment required before February 2021). If the decision is taken to go ahead with the exhibition, we will contact all the Members who have booked stands and proceed with invoicing and other arrangements. This will be at the end of January 2021.

## **3. ITCO's ACC 4th Edition (2017) – now published with a new design**

The 4th edition of ITCO's ACC (Acceptable Container Condition) Inspection Guidance was published in September 2017.

The document has now had a re-design – so that it is in line with ITCO's other Technical Guidance documents, to reflect ITCO's professional image.

No changes have been made to ACC criteria. A few minor editorial clarifications have been incorporated into the introduction. Accordingly, the newly designed format continues as the 2017 edition

Members will be aware that ACC Inspection Guidance provides guidance to determine the acceptable condition of a general-purpose tank and guidance for when the condition of a tank component should be repaired. ACC is designed for use when tanks are inspected at the time of interchange between one party to another, such as between owner, operator, lessee, shipper, service provider depot and carrier.
