# 1. Tank entry safety mark

ITCO promotes continued improvement of tank container safety through its Conferences, Work Groups and Guidelines.

Members are invited to propose safety initiatives.

Hoyer investigated procedures relating to tank entry and are proposing - as an additional safety provision - to display a tank entry warning mark.

Tank entry permit procedures (entry into a confined space procedures) are essential and are required by health and safety legislation.

Regrettably, research indicates that, on occasions, there might be a risk of improper tank entry and consequential risk of injury or death.

The proposed tank entry safety mark is additional to the required entry permit and the essential safety training of personnel. The mark will be fitted to the man-lid and adjacent to the man-lid

The proposal seeks other tank users support for the initiative.

We welcome your feed-back on all aspects including:

## 2. RID-ADR Meeting – March 2020

ITCO will attend the next RID-ADR meeting, taking place next month. Members who wish to comment on the agenda should contact the technical secretary (<u>rubery@itco.org</u>). The agenda includes a number of tank container items including:

## 20/24 Structural serviceable

Freight containers, including tank containers /portable tank are required to be structurally serviceable in compliance with RID-ADR 7.1.4 general provisions.

The existing provisions require conditions exceeding ITCO ACC criteria. For example, RID-ADR 7.1.4 refers to "major defects are dents or bends in structural members greater than 19mm in depth"



The proposal to RID-ADR is to amend 7.1.4 to align with the recently agreed amendment to UN Model Regulation which provides for a requirement for structural serviceability but without prescribing detailed damage criteria.

The proposal has been supported by CEFIC and ITCO.

#### 19/20 Inspection WG

- 6.8.1.5.1 Type approval and inspections during manufacture are required to be undertaken by an AIB (authorised inspection body) recognised by the country of the operator's registration. Without continuation of existing reciprocal agreements to recognise AIB's, this is particularly an issue for leasing companies where the operator is often unknown at the time of manufacture.
- 6.8.1.5.5 Entry into service verification. This requires each tank entering into service or transferred to a new service in another country, to be inspected by an AIB of the country of the operator's registration.
- 6.8.1.5.6 Intermediate, periodic or exceptional inspection requires the operator of the tank to engage "a single inspection body for each intermediate, periodic or exceptional inspection".
- AIB's current reciprocal agreements between countries might not continue in its present form. AIB's accredited in one country would not be free to offer services in another country without obtaining either accreditation or a joint arrangement.

#### 20/6. Extra-large tanks e.g. BASF 73000 litre

UIC continue their investigation into extra- large tanks that compete with rail-tank wagons. Two items from the investigation:

- Requirement that all tanks container are fitted with reinforcement plates below fittings e.g. walk-way to tank attachment
- Hinged man-lids maximum of 6 bar requiring flanged man-lids for 10 bar tanks.

#### 20/01 Intermediate test T75

Proposes to omit first intermediate test from road tank vehicles. If this agreed it should be proposed to apply to 6.8 tank containers too

#### 20/33 6.8 shell thickness calculation

Proposes to calculate thickness according to calculation pressure rather than the existing calculation pressure and test pressure. This might slightly reduce shell thickness.
